HORIZON HOUSE

ADMISSION APPLICATION & AGREEMENT

The Mission of Wide Horizon is to provide Christian Science nursing, facilities, and support for those seeking healing accomplished through complete reliance on Christian Science as taught by Mary Baker Eddy.

(All information provided in this application will be held as confidential as applicable.)

Section 1: Requirements to be a Resident of Horizon House

The applicant agrees that he/she:

- Is a member of The Mother Church and/or a Christian Science branch church or a Christian Science Society.
- Supports the Cause of Christian Science and abides by the Tenets of Christian Science (*Church Manual*, p.15).
- Seeks an active life of spiritual growth in accordance with the teachings of Christian Science.
- Regularly studies the Christian Science Bible Lesson, a lesson on which the prosperity of Christian Science largely depends (see *Church Manual*, Art. III, Sec. 1, p. 31).
- Is able to walk without assistance between Horizon House and the Main Building.
- Will eat at least the noon meal each day in the Main Building dining room.
- Will participate in Activities in the Main Building as much as possible (such as the daily Bible Lesson group activity).
- Does not need the assistance of another person for dressing, eating, bathing, grooming or using the toilet.
- Will give up one's room and move to Main Building, or to some other setting away from Wide Horizon, if the Director of Christian Science Nursing and Executive Director agree that the individual's mental or physical abilities compromise their ability to live safely and independently at Horizon House.

- Upholds and abides by the standards of Christian Science: does not drink alcoholic beverages or use tobacco in any form; does not use and is not dependent upon any prescription or non-prescription drug(s); is not under the care of a medical doctor; will receive no form of material medical care, medication, diagnosis or medical treatment while on the Wide Horizon premises.
- Will maintain radio and television volumes at a level that does not disturb other guests.
- Will give up his/her room if he/she chooses to be away from Wide Horizon for more than 30 days for any reason.
- Will provide Wide Horizon with an "Advance Care Directive" (Healthcare Power of Attorney), a General Power of Attorney, and a completed general Wide Horizon Admission Agreement at the time of occupancy.
- Will pay all invoices promptly.
- And will be bound by the provisions of this document and all published policies, rules and regulations governing the guests and residents of Wide Horizon.

Section 2: Amenities Furnished to Residents of Horizon House

Wide Horizon will provide:

- A private furnished (if desired), heated and air-conditioned apartment. (<u>Each room is complete</u>. Please do not move any furniture or amenities from one room to another without permission from the Director of Christian Science Nursing.)
- Microwave oven, compact refrigerator, and linens (if desired).
- Housekeeping and laundry service once per week.
- One unassigned parking space near Horizon House for the resident's vehicle (if needed).
- Three meals each day—breakfast and supper in the Horizon House common area and lunch (the main meal) served in the Main Building dining room, or served in Horizon House during inclement weather.
- Utilities: electricity, heating/cooling, water, Wi-Fi.
- Landline telephone and an HDTV with Air Antenna. (Resident will arrange and pay for special telephone and/or cable/satellite TV hookups separately.)
- Emergency Call System for contacting Christian Science nursing staff from the unit.
- Audio system programming, including Christian Science church services.
- Activities in the Main Building.
- A secured building. (Keypad locking entry door and security cameras.)
- Twice daily checks on resident (if desired).
- Occasional Christian Science nursing services/supplies, which are available at an extra charge.

Section 3: Financial Commitment & Application

Rental rate for each Horizon House apartment is \$3,000 per month.

Rent is payable one month in advance upon occupancy and thereafter on the first day of each month. A security deposit of \$1,000 is also required, payable at the time this application is approved and a move-in date is set. Wide Horizon reserves the right to raise the rental rate at any time, only after a 30-day written notice is given to the resident. Wide Horizon operates on a not-for-profit basis. In order to ensure a continuing and sound operation, it is necessary for Wide Horizon to be assured of each prospective resident's ability to financially meet initial payments and/or monthly fees as well as to satisfy their future personal needs.

Section 4: Horizon House Occupancy Rules

- 1. Wide Horizon's Christian Science nursing staff reserves the right to request a resident call a Christian Science Practitioner for help through Christian Science treatment, and/or to call on behalf of the resident when it appears to be necessary.
- 2. No pets are permitted (except those owned by day visitors of the resident) in Horizon House.
- 3. Personal shopping service and assistance, and transportation to and from personal appointments, are available at an extra charge.
- 4. Radio and television volumes must be kept at a level which does not disturb other residents.
- 5. State law, (Wide Horizon is licensed as a "Nursing Care Facility"), prohibits the use of electrical devices such as hot plates, toasters, coffee pots, and non-compliant space heaters in individual units of Horizon House. The kitchenette in the common area includes a coffee pot, which may be used by residents.
